National Development Bankof Palau announced as finalist at global green awards

Bank's support for low-carbon homes puts it in the running for 2013 Ashden Awards

The National Development Bank of Palau has been announced as a finalist in the 2013 Ashden Awards, the world's leading green energy prize. The Bank is being recognised for its programme to encourage energy-efficient households on the island.

The National Development Bank of Palau is leading the way with its programme to integrate energy efficient measures into its mortgage lending for new builds, drastically cutting the need for energy-intensive air-conditioning.

Over the past three years nearly all the new-build homes on the islands have included approved energy efficiency measures like natural ventilation or white painted roofs. Some houses have also received energy-efficient refurbishment or installed solar PV.

The Ashden Awards were founded in 2001 to encourage the greater use of sustainable energy to reduce poverty and tackle climate change. The National Development Bank of Palau joins three other finalists in the Awards for Small Island Developing States, a new category launched this year with the support of the World Bank and the Energy Sector Management Assistance Program (ESMAP) through the SIDS DOCK support program.

Sandra D. Mincer, CEO and President of the National Development Bank of Palau said:

"The National Development Bank of Palau is honored and proud to have been nominated for such an auspicious award and to compete with many innovative programmes that address energy efficiency and the sustainable use of clean energy. To be selected as a finalist for the Ashden Awards is humbling when we are only doing what we do to assist the nation's grassroots in improving their lives."

"This innovative lending programme that integrates energy efficiency measures into the mortgage for the house can be replicated across other islands."

Two winners of the 2013 Awards for Small Island Developing States will be announced at a prestigious ceremony at the Royal Geographical Society in London, UK on 20 June 2013.
